**DRAW YOUR ATTENTION TO!**

1. For applicants for academic titles, according to the "Procedure for conferring academic titles to scientific and scientific-pedagogical workers" dated January 14, 2016 No. 13 (as amended on 03.03.2017), scientific works included in the scientometric databases Scopus or Web of Science, by decision Academic Council of a higher educational institution may be replaced by the publication of a monograph in English in one of the international publishing houses (p. 4., p. 2, R. II).

2. **Order of the Ministry of Education and Science of Ukraine** "On the publication of the results of dissertations for obtaining the scientific degrees of Doctor and Candidate of Sciences" 09/23/2019 No. 1220: According to paragraphs. 47 clause 4 of the Regulation "On the Ministry of Education and Science of Ukraine", approved by the Resolution of the Cabinet of Ministers of Ukraine on October 16, 2014 No. 630 (as amended on 08.07.2020), and clause 12 of the "Procedure for conferring scientific degrees", approved by the Resolution of the Cabinet of Ministers of Ukraine 24 July 2013 No. 567 (as amended on July 23, 2020):

1) the main scientific results of the dissertation (made in the form of a manuscript, monograph, scientific report) for the scientific degree of Doctor of Science should be stated in no less than 20 scientific publications that reveal the main content of the dissertation. Such scientific publications include: no more than two monographs (sections in collective monographs);

2) the main scientific results of the dissertation for the scientific degree of candidate of sciences must be stated in at least three scientific publications that reveal the main content of the dissertation. These scientific publications include:

articles in scientific journals included in the list of scientific publications of Ukraine (instead of one article, a monograph or a section of a monograph published in co-authorship may be credited).

3. According to the Project "Procedure for conferring scientific degrees" developed by the National Agency for Quality Assurance in Higher Education:

1) the main scientific results of the dissertation, competition for the degree of Doctor of Philosophy, in the form of a manuscript, should be presented in at least 3 scientific publications that reveal the main content of the dissertation. Such scientific publications include: articles in scientific journals included in the list of scientific professional publications of Ukraine (instead of one article, a monograph or a section of a monograph published in co-authorship may be credited);

2) the main results of the scientific achievement that is submitted for the degree of Doctor of Science must be stated in at least 20 scientific publications. These scientific publications include: no more than two (two) monographs (sections in collective monographs).

**The monograph provides for the following tentative titles of sections:**

1. Financial markets, insurance and government fiscal policy.
2. Development of the agro-industrial complex and rural areas.
3. National economy under neo-industrialism.
4. Entrepreneurship, accounting policy and management of large, medium and small business structures.
5. Industry of hospitality and tourism.
6. Legal regulation of economic and social processes.
7. Financial, legal and organizational aspects of ensuring the educational process in a pandemic.

The titles of the sections can be specified according to the materials presented.

To post materials in the monograph, the authors must by October 15, 2020:

- send to the editor:
- subsection or section of the monograph (the number of co-authors should not exceed two people);
- Doctor of Science review (for authors who do not have a scientific degree);
- information about the author (s) in Ukrainian and English (in a separate file).
- pay the invoice for the publication of materials. }

The electronic file of the monograph will be dispatched until November 15, 2020, at the indicated email addresses.

Distribution of hard copies will be carried out until December 01, 2020, at the indicated addresses of the New mail offices at the expense of the recipient.

Until December 15, 2020, the monograph will be posted on the website of the Academy of Economic Sciences of Ukraine.

**GUIDELINES FOR EDITING**

Working languages of the monograph are Ukrainian, English, and German.

**Text design:**

Length: 10-20 pages, single-sided. At the request the author can submit a separate section divided into subsections of 50-75 pages.

Software and format: the text should be in MS Word 6.0 format (\*.doc ) not older than the **Version Word-2003**. Font: Times New Roman. Font size: 10 pt.

Line spacing: manuscript text should be single spaced. Paragraph indentation: 1 cm. **Page format: A5**. Margins: 20 mm.

Design of formulas, figures and tables (Font: Times New Roman. Font size: 8 pt. Line spacing: single spaced). Figures and tables should be black and white in MS Office and they must be signed, numbered sequentially as they appear using Arabic numerals, and a caption should appear directly below of each figure (**color drawings, graphics, scanned files and photos are not allowed**). All diagram tables and figures should be **black and white, have a book orientation not do not exceed one page**.

Doing so on the literary dzherela huddle at the sight of the signs on the sidelines. The list of references must be made in accordance with the **National Standard of Ukraine DSTU 8302: 2015**.

The text must be done in accordance with the requirements and appropriate stylistic editing.

*The received materials undergo review process. In the case of a positive decision, the author receives an invoice for payment which is sent to the author to pay for the publication of the material.*

**FINANCIAL REQUIREMENTS**

**Publication Cost is:**

- **to receipt a printed copy – 700 UAH for 10-12 pages (full or not full);**
- **to receipt the only electronic version in PDF format - 500 UAH for 10-12 pages (full or not full);**

**Pages above the specified amount are paid at the rate of 50 UAH for each additional page (full or not full).**

The cost of an extra copy is **200 UAH**.

The cost of publication includes reviewing, prototyping, and monograph publication.

**For foreign authors the cost of publication is € 20 (electronic version in PDF format); € 30 (printed version). The postage costs for the delivery of a copy to the author are additionally paid in accordance with the tariffs established by Ukrposhta.**

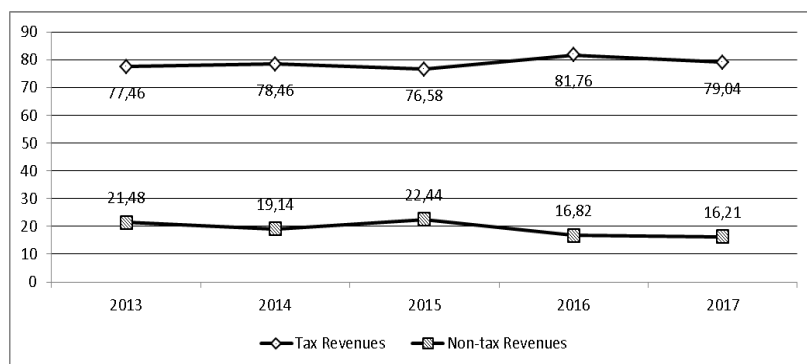

### 1.2 Fiscal Role of Non-tax Revenues in the System of Government Revenues of Ukraine

The challenges Ukraine faced after the Revolution of Dignity in 2014 led to the necessity for a number of major reforms in the fiscal area, of which budget decentralisation and restructuring of budget revenues at different levels are of central importance.

Trends in the generation of government revenues in 2013-2017, as shown in Fig. 1, support the argument that the core pool of the government's centralised financial resources is generated through the tax form of nationalisation of GDP and is complemented by a range of non-tax payments, which ultimately enables the government to perform its functions.

To determine the fiscal role of non-tax revenues in generating Ukraine's government revenues, it is advisable to analyse the composition and structure of total government revenues (Table 2).
